BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$11,000 \$12,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$10,000 from District 9; \$500 each from Districts 23, 1, 13; \$250 each from Districts 14, 3, 2; through the Office of Management and Budget, to the World Affairs Council of Kentucky/Southern Indiana, Inc. for technology, communications and operational support.
