**SECTION I:** The following appropriation for the listed contract is hereby approved:

**POLICE**

\$92,000.00 for a Professional Service Contract with University Medical Center, Inc. d/b/a University of Louisville Hospital/James Graham Brown Cancer Center to provide a coordinator for the Sexual Assault Forensic Examiner ("SAFE") Program from July 1, 2021 through June 30, 2022.

**SECTION II:** The SAFE Program will provide to Metro Council an annual report no later than March 1<sup>st</sup> of each year. The report will include a complete review of the current processes, peer-review, and exam outcomes performed by the SAFE Program.

**SECTION III:** This Resolution shall take effect upon its passage and approval.
