AN ORDINANCE AMENDING ORDINANCE NO. 053, SERIES 2018, RELATING TO AN **APPROPRIATION** TO KENTUCKY SHAKESPEARE FESTIVAL, INC. FOR **ASSOCIATED** WITH PERFORMANCES OF COSTS SHAKESPEARE IN THE PARKS. BY INCREASING THE AMOUNT APPROPRIATED FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS FROM \$1,000 TO \$2,000.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: SECTION I of Ordinance No. 053, Series 2018 is hereby amended as follows:

SECTION I: The sum of \$24,000 \$26,000 \$27,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 each from Districts 6, 1, 2, 4, 5, 9, 10, 12, 14, and 17, and 23; \$1,500 from District 20; \$1,000 each from District 7 and 9; and \$500 each from Districts 8, 13, 15, 21, and 25; through the Office of Management and Budget, to Kentucky Shakespeare Festival, Inc. for costs associated with performances of Shakespeare in the Parks.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
