**WHEREAS,** the Metro Government wishes to take advantage of this funding opportunity through the Louisville Metro Police Department.

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to accept a donation of 16,000 square feet of office space, with an annual value of \$112,000, for a maximum term of five years from Titan Research & Development Louisville LLC. The space will be used by the Louisville Metro Police Department for office space, warehouse storage, staging area, and for exercise, training and drills.

**SECTION II:** This Resolution shall become effective upon its passage and approval.
