**A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$1,100,000 OF FUNDING FROM THE COMMONWEALTH OF KENTUCKY TRANSPORTATION CABINET AMENDED WITHIN THE ENTIRE FUNDING SCOPE OF THE COOPER CHAPEL I PROJECT TO BE ADMINISTERED BY THE DEPARTMENT OF PUBLIC WORKS & ASSETS.**

**WHEREAS,** the Metro Government wishes to enter into this agreement through the Department of Public Works & Assets.

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$1,100,000 of amended funding within the scope of the Cooper Chapel I project. \$600,000 is to be re-allocated from the utility phase and \$500,000 is re-allocated from KYTC's oversight funding to complete construction elements on the Cooper Chapel I

section between Preston Highway and Smyrna Parkway.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
