**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY**

**METRO GOVERNMENT (THE COUNCIL) AS**

**FOLLOWS:**

**SECTION I:** The sum of ~~\$12,000~~ \$14,500 \$15,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 \$2,750 from District 14; \$2,000 from District 4; \$1,000 each from Districts 12, 13, 15, 21, 25, 6, 2; \$500 each from Districts 1, 5, 10, 9; \$300 from District 3; \$250 each from Districts 7, 8, 24; \$200 from District 16, through the Office of Management and Budget, to Metro United Way, Inc. for programming expenses associated with implementing the Volunteer Income Tax Assistance Program (VITA).

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
