That there is authorized the following expenditures for the operation of the Jefferson County Sheriff's Office during the calendar year 2016. The total sum of \$21,521,640 shall be allocated as follows:

There is further authorized a personnel complement of 328 employees. The total estimated revenues are \$21,829,458. Therefore, the anticipated 2016 year-end cumulative term surplus will total \$227.
