### Schedule A

#### Fiscal Year 2016 Budget

That there is authorized the following expenditures for the operation of the Jefferson County Sheriff's Office during the calendar year 2016. The total sum of \$21,521,640 shall be allocated as follows:

<b>Personnel</b>	<b>\$18,770,240</b>
<b>Operating</b>	<b>\$ 2,367,400</b>
<b>Capital</b>	<b><u>\$ 384,000</u></b>
<b>TOTAL</b>	<b>\$21,521,640</b>

There is further authorized a personnel complement of 328 employees. The total estimated revenues are \$21,829,458. Therefore, the anticipated 2016 year-end cumulative term surplus will total \$227.
