FOR COSTS ASSOCIATED WITH THE LO WATERFRONT 4TH CONCERT (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,250~~ \$6,250 \$11,300 is hereby appropriated from Neighborhood

Development Funds, in the following manner: \$1,000 each from Districts 15, 12, 25, 4, 7, 8, 14, 24; \$500 each from Districts 13, 5, 2, 16; \$250 each from Districts 6, 1, 3, 21; \$300 from District 17; through the Office of Management and Budget, to the Louisville Orchestra, Inc. for costs associated with the LO Waterfront 4th Concert.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
