**Section I:** That the zoning of the property located at 7500 Crestline Road containing 1.681 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 14ZONE1053, is hereby changed from R-5A Multi-Family Residential to PRD Planned Residential Development; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 14ZONE1053.
