**Section I:** That the zoning of a portion of the property located at 2537-2551 W. Market Street and 111-125 South 26<sup>th</sup> Street and being in Louisville Metro is hereby changed from OR-2 Office/Residential to C-1 Commercial on 0.247 acres as more particularly specified in the minutes and records of the Planning Commission in Case No. 17246; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 17246.

**Section II:** This Ordinance shall take effect upon passage and approval.
