WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government (the

"Council") has considered the evidence presented at the public hearing held by the Louisville Metro

in the minutes and records of the Planning Commission in Case No. 15ZONE1034; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission for

Now therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:

Section I: That the zoning of the property located at 2609 Shining Water Drive containing

4.76 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 15ZONE1034, is hereby changed from R-6 Multi-Family Residential to PEC Planned Employment Center; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 15ZONE1034.

Section II: This Ordinance shall take effect upon its passage and approval.
