A RESOLUTION TO APPROVE METRO COUNCIL'S RECOMMENDATIONS TO THE MAYOR FOR MEMBERSHIP ON THE CIVILIAN REVIEW & ACCOUNTABILITY BOARD. SPONSORED BY: COUNCIL MEMBERS MCCRANEY, HOLLANDER, KRAMER AND COUNCIL PRESIDENT DAVID JAMES

WHEREAS, on November 19, 2020, Metro Council passed Ordinance No. 147, Series 2020 creating the Civilian Review & Accountability Board and the Office of Inspector General, and the Ordinance became effective on December 2, 2020; and

WHEREAS, Section II of that Ordinance provides that for each of three Board positions, the Mayor shall appoint from lists of recommendations provided by Metro Council, and requires Metro Council to provide the Mayor with a list of two names for each of the three positions; and

WHEREAS, to ensure experience and continuity over time, Section II further provides that the initial Board appointments shall be for staggered terms; and

WHEREAS, Section II authorizes Metro Council to make three initial board appointment recommendations, one for a term of one year, one for a term of two years, and one for a term of three years; and
