## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$15,000 is hereby appropriated from District 5 Neighborhood Development Funds to Metro Parks Department for various activities and programs to be held in parks and community centers throughout District 5.

**SECTION II:** The sum of \$5,000 is hereby appropriated from District 6 Neighborhood Development Funds to Metro Parks Department for various activities and programs to be held in parks and community centers throughout District 6.
