AN ORDINANCE AMENDING ORDINANCE NO. 101, SERIES 2014 PERTAINING TO THE 2014-2015 CAPITAL BUDGET, BY ESTABLISHING A NEW PROJECT TITLED FOURTH STREET SIDEWALKS TO BE ADMINISTERED BY DEVELOP LOUISVILLE.

Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:

SECTION I: Part I. O. Develop Louisville of Ordinance No. 101, Series 2014 is hereby amended as follows:

SECTION II: Louisville Metro Government and Commonwealth of Kentucky Transportation Cabinet both wish to enter into an agreement to fund the construction of sidewalks, curbing and sustainable infrastructure on Fourth Street and West Chestnut Street through a new project as listed in Section I of this Ordinance. This Ordinance fulfills the Resolution requirement from the Commonwealth of Kentucky Transportation Cabinet by further recognizing the authority granted by KRS 67C.105(5)(h) for the Mayor to enter into this agreement.

SECTION III: The Council has determined that the funds requested in this ordinance will be expended for a public purpose.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
