**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The total of ~~\$9,000~~ \$15,100 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 each from Districts 7 and 19; \$2,000 from District 21; \$1,000 each from Districts 11 and 17; ~~and~~ \$500 each from Districts 2, 9, 10, 13, 14, 16, 18, 20, 22, and 23; \$384 from District 8; \$250 each from Districts 4 and 5; and \$216 from District 25; through the Office of Management and Budget, to TreesLouisville, Inc. for programming expenses associated with the Jefferson County High School Freshman 10,000 Tree Giveaway.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
