SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funds of \$290,000 for the right-of-way phase of the A.B. Sawyer Park shared-use path connector to the existing Forest Green Greenway segment.
