**WHEREAS:** The Legislative Council of the Louisville/Jefferson County Metro Government (the Council) heretofore approved Ordinance No 44, Series 2013 on March 20, 2013, appropriating the sum of \$7,700 from Metro Council District Neighborhood Development Funds (NDF) in the following manner: \$1,500 from District 25; \$1,000 each from Districts 12, 13, 24; \$500 each from Districts 6, 3, 14; \$400 each from Districts 23, 8; \$300 each from Districts 10, 15, 21; to Valley View Baptist Church, Incorporated for expenses connected with its Shop with a Hero program;

**WHEREAS:** The Council desires to rescind Ordinance No 44, Series 2013, and have the funds therein allocated

returned to the NDF funds of those Districts accordingly.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL AS FOLLOWS:**

**SECTION 1:** That Ordinance No 44, Series 2013 is hereby rescinded and the funds therein allocated to shall be returned to the NDF funds of those Districts accordingly.

**SECTION 11:** This Ordinance shall take effect upon its passage and approval.
