**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$18,500 \$25,750 \$45,250 is hereby appropriated from Neighborhood Development Funds in the

following manner: \$10,000 from Districts 12, 19; \$5,000 from Districts 11, 7; \$2,000 from District 10; \$1,500 from District 15; \$1,000 from Districts 14, 17, 1, 4, 13, 24, 25; \$500 each from Districts 16, 9, 22, 20, 2, 3, 8, 6, 21; \$250 from District 18; through the Office of Management and Budget, to the Volunteers of America of Kentucky, Inc., for Phase 2 renovations to the Freedom House which houses the Women’s Addiction Recovery Services.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
