BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$48,000~~ \$54,000 from Neighborhood Development Funds in the following manner: \$7,500 from District 23; \$12,000 from District 12; \$6,000 from Districts 5, 2; \$4,500 each from Districts 3, 4, 6;

\$3,000 from District 11, 21; \$1,500 each from Districts 8, 17; through the Office of Management and Budget, to Blue Apple Players, Inc., for programming expenses associated with performances of "The Three Little Pigs: The Wild West Will Never Be The Same."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
