ORDINANCE NO. ____, SERIES 2014

AN ORDINANCE APPROPRIATING \$48,000 \$54,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$7,500 FROM DISTRICT 23; \$12,000 FROM DISTRICT 12; \$6,000 FROM DISTRICTS 5, 2; \$4,500 EACH FROM DISTRICTS 3, 4, 6; \$3,000 FROM DISTRICT 11, 21; \$1,500 EACH FROM DISTRICTS 8, 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO BLUE APPLE PLAYERS, INC., FOR PROGRAMMING EXPENSES ASSOCIATED WITH PERFORMANCES OF "THE THREE LITTLE PIGS: THE WILD WEST WILL NEVER BE THE SAME(<u>As Amended</u>)."

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$48,000 \$54,000 from Neighborhood Development Funds in the following manner:

\$7,500 from District 23; \$12,000 from District 12; \$6,000 from Districts 5, 2; \$4,500 each from Districts 3, 4, 6;

\$3,000 from District 11, 21; \$1,500 each from Districts 8, 17; through the Office of Management and Budget, to Blue Apple Players, Inc., for programming expenses associated with performances of "The Three Little Pigs: The Wild West Will Never Be The Same."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
