**AN ORDINANCE CHANGING THE ZONING FROM R-4 RESIDENTIAL SINGLE FAMILY TO R-5A RESIDENTIAL MULTI-FAMILY WITH AN ALTERNATIVE CONNECTIVITY PLAN ON PROPERTY LOCATED AT 7506 BEULAH CHURCH ROAD CONTAINING 8.85 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 16ZONE1048). (AS AMENDED)**

**WHEREAS**, The Legislative Council of the Louisville/Jefferson County Metro Government (the “Council”) has considered the evidence presented at the public hearing held by the Louisville Metro Planning Commission and the recommendations of the Planning Commission and its staff as set out in the minutes and records of the Planning Commission in Case No. 16ZONE1048;

**WHEREAS**, the Council concurs in and adopts the findings of the Planning Commission for the zoning change in Case No. 16ZONE1048 and approves and accepts the recommendations of the Planning Commission as set out in said minutes and records; and

WHEREAS, the approval of this plan in no way negates the authority of the Neighborhood Plan.

**NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**SECTION I:** That the zoning of the property located at 7506 Beulah Church Road containing 8.85 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 16ZONE1048, is hereby changed from R-4 Residential Single Family to R-5A Residential Multi-Family with an alternative connectivity plan authorized by Section 5.9.2.A.1 of the Land Development Code; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 16ZONE1048.

**SECTION II:** The following binding element has been added:

11. The connection from Applevue Lane to Appletree Way shall be labeled as "No Parking" on both sides.

**SECTION III:** This Ordinance shall take effect upon its passage and approval.
