#### BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The amount of \$13,500 is hereby appropriated from District 11 Neighborhood

Development Funds, through the Office of Management and Budget, to the Jefferson County Public

Education Foundation, Inc. for the installation of new playground equipment, which will benefit the

school and the surrounding community, at Cochrane Elementary School.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended
