**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$110,000 of funding for the right of way phase for the safe routes to school project along Third Street Road from Clayborne Road to Bruce Avenue serving Kenwood Elementary School and Lassiter Middle School further south.
