Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:

SECTION I: Part I., A., 2. Louisville Metro Council, of Ordinance No. 102, Series 2014, is hereby amended as follows:

2. LOUISVILLE METRO COUNCIL

a. General Operations General Fund ~~4,993,300~~ 5,005,300

b. Neighborhood Development Fund General Fund ~~2,777,800~~ 2,765,800
