HOURS, WORKING CONDITIONS, **BENEFITS** AND OTHER TERMS AND CONDITIONS OF EMPLOYMENT BETWEEN LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AND THE **FEDERATION** OF STATE, COUNTY AND AFL-CIO, EMPLOYEES. LOCAL MUNICIPAL 2629 CONCERNING CERTAIN CIVILIAN MEMBERS OF THE LOUISVILLE METRO CORRECTIONS DEPARTMENT.

WHEREAS, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and the Federation of State, County and Municipal Employees, AFL-CIO, Local 2629 concerning certain civilian members of the Louisville Metro Corrections Department.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Collective Bargaining Agreement (August 18, 2015 - June 30, 2018)
