**AN ORDINANCE APPROPRIATING \$10,000 \$10,250 \$11,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 9, 12, AND 24; \$625 FROM DISTRICT 13; \$500 EACH FROM DISTRICTS 1, 2, 4, 7, 8, 10, 13, 14, 15, 19, 20, 21, AND 26; \$250 EACH FROM DISTRICTS 5, 6, 20, 22, 23, AND 25; AND \$125 FROM DISTRICT 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE COALITION FOR THE HOMELESS, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH PROJECT STAND DOWN (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$10,000~~ \$10,250 \$11,000 from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 9, 12, and 24; \$625 from District 13; \$500 each from Districts 1, 2, 4, 7, 8, 10, 13, 14, 15, 19, 20, 21, and 26; \$250 each from Districts 5, 6, 20, 22, 23, and 25; and \$125 from District 17; through the Office of Management and Budget, to the Coalition for the Homeless, Inc. for programming expenses associated with Project Stand Down.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
