BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$400 \$1,000 is hereby appropriated from District 11 Neighborhood Development Funds as follows: \$400 from District 11; \$600 from District 21, by amending Ordinance No. 136, Series 2015, which approved \$17,250 in funding, for a new total of \$17,650 \$18,250; through the Office of Management and Budget, to the War Against Violence Corporation for costs associated with the "YouthAlert!" Violence Prevention/Health Community Outreach Program.
