BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$10,250~~\$16,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; ~~\$1,500~~\$1,500 from District 14; \$1,000 each from Districts 3, 10, 13, ~~15, and~~15, and 24, and 25; \$500 each from Districts 1, 2, 7, and 9, and 21; and \$250 from Districts 4, 5, 17, and 22; through the Office of Management and Budget, to Harbor House of Louisville, Inc. for program expenses associated with the 15<sup>th</sup> annual Ken-Ducky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public

purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
