**AN ORDINANCE APPROPRIATING ~~\$7,000~~ \$18,200 FROM DISTRICT 22 IN NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$11,200 FROM DISTRICT 21 AND \$7,000 FROM DISTRICT 22; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO CHILDREN HAVE OPTIONS IN CHOOSING EXPERIENCES, INC. (C.H.O.I.C.E., INC.), FOR THE "DARE TO DREAM" SPORTS LEADERSHIP AND MENTORING PROGRAM (AS AMENDED).**

**SPONSORED BY: COUNCIL MEMBERS ENGEL AND LANSHIMA**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$7,000~~ \$18,200 is hereby appropriated from District 22 Neighborhood Development Funds, in the following manner: \$11,200 from District 21 and \$7,000 from District 22; through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for the "Dare to Dream" sports leadership and mentoring program.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
