FOR COSTS ASSOCIATED WITH A MEMORIAL FOR LOUISVILLE METRO POLICE DEPARTMENT FALLEN OFFICER NICK RODMAN (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$10,000~~ \$13,444 hereby appropriated from the Neighborhood Development Funds ~~of~~ in the following manner: \$10,000 ~~\$8,000~~ from District 5; \$500 from Districts 6, 7, 12, 14, and 16; \$250 from Districts 1, 2, 3, 9, 10, 13, 17, 20, 21, and 22, and 24; \$144 from District 4; \$50 from District 25; through the Office of Management and Budget, to Emily Wright Fund, Inc. for costs associated with a Memorial for Louisville Metro Police Department Fallen Officer Nick Rodman.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
