**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$12,000~~ \$12,750 is hereby appropriated from Neighborhood Development

Funds, in the following manner: \$5,000 from District 21; \$1,500 from District 8; \$1,000 from District 15; \$500 each from Districts 9, 3, 13, 6, 1, 2, 5, 25, 4, 12; \$250 from District 10; through the Office of Management and Budget, to the Kentuckiana Pride Foundation, Inc. for costs associated with the production of the festival, parade and concert.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
