**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$8,400~~ \$8,650 \$11,650 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$2,000 from District 9; \$1,000 each from Districts 26, 4, 24, 14; \$500 each from Districts 14, 5, 8, 10, 15, 13, 12, 2, 3, 21, 25; \$400 from District 1; \$250 from District 6; through the Office of Management and Budget, to the Louisville Metro Affordable Housing Trust Fund, Inc. (LAHTF) for a fiscal, economic and social impact study of additional spending from a one-percent increase in the insurance premium tax to fund affordable housing in Louisville Metro to the LAHTF, by the University of Louisville Urban Studies Institute.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
