in the minutes and records of the Planning Commission in Case No. 16ZONE1032; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission for

the zoning change in Case No. 16ZONE1032 and approves and accepts the recommendations of the

Planning Commission as set out in said minutes and records;

#### NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE

#### LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That the zoning of the property located at 3403 Stony Brook Drive and Tax Block 45, Lot 927 containing 18.1 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 16ZONE1032, is hereby changed from R-4 Residential Single Family to R-5 Residential Single Family; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 16ZONE1032.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
