**AN ORDINANCE APPROPRIATING \$6,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 EACH FROM DISTRICTS 13, 12, 14 AND 15; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. TO PROVIDE FUNDS FOR EXPENSES RELATED TO SOUTH LOUISVILLE BUY LOCAL FAIR ON OCTOBER 8, 2017.**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$6,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 each from Districts 13, 12, 14 and 15; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc. to reimburse funds spent on the South Louisville Buy Local Fair, which was held on October 8, 2017, including advertising/design, printing, and distribution for billboards and posters advertising the event; bus and venue rental; event insurance; and event volunteer related compensation.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended

for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
