**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Kentucky Transportation Cabinet to accept \$100,000 of additional Federal Highway Administration funding to continue design work for improvements along Dixie Highway from Crums Lane to Broadway which this segment is specific to Dixie Highway from Garland Avenue to Broadway.
