**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$8,630~~ \$10,130 is hereby appropriated from Neighborhood Development Funds, in the following manner: ~~\$3,000~~ \$3,500 from District 21; \$1,500 from District 8; \$580 from District 1; \$500 each from Districts 9, 15, 10, 6; 26; 4, 12, 25; \$300 from District 3; \$250 from District 2; through the Office of Management and Budget, to Kentuckiana Pride Foundation, Inc., for costs associated with the Kentuckiana Pride Parade and Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
