**AN ORDINANCE APPROVING THE VISION RUSSELL NEIGHBORHOOD PLAN AND APPROVING ITS EXECUTIVE SUMMARY AS AN AMENDMENT TO THE PLAN 2040 COMPREHENSIVE PLAN (CASE NOS. 18NEIGHPLAN1007 & 18NEIGHPLAN1008).**

**WHEREAS**, the Louisville Metro Planning Commission held a public hearing on July 18, 2019 on approving the Vision Russell Neighborhood Plan and approving an amendment to the Plan 2040 Comprehensive Plan to incorporate the Plan’s Executive Summary in cases 18NEIGHPLAN1007 & 18NEIGHPLAN1008; and

**WHEREAS**, the Planning Commission found that the Vision Russell Neighborhood Plan conforms to the adopted Guidelines and Policies of the Plan 2040 Comprehensive Plan and the incorporation of the Vision Russell Neighborhood Plan’s Executive Summary into Plan 2040 also conforms to the adopted Guidelines and Policies of the Plan 2040 Comprehensive Plan; and

**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government (the “Council”) has considered the evidence presented at the public hearing held by the Louisville Metro Planning Commission and the recommendations of the Commission and its staff as set out in the minutes and records of the Planning Commission in Case Nos. 18NEIGHPLAN1007 & 18NEIGHPLAN1008; and

**WHEREAS**, the Council concurs in and adopts the findings and recommendations of the Planning Commission approving the Vision Russell Neighborhood Plan and approving an amendment to Plan 2040 to incorporate the Executive Summary of the Vision Russell Neighborhood Plan in Case Nos. 18NEIGHPLAN1007 & 18NEIGHPLAN1008, and approves and accepts the recommendations of the Planning Commission as set out in said minutes and records.

**NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:**

**SECTION I:** That the Vision Russell Neighborhood Plan included in the records of the Planning Commission in Case Nos. 18NEIGHPLAN1007 & 18NEIGHPLAN1008 is hereby adopted.

**SECTION II:** The Executive Summary of the Vision Russell Neighborhood Plan included in the minutes and records of the Planning Commission in Case Nos. 18NEIGHPLAN1007 & 18NEIGHPLAN1008 is hereby adopted as an amendment to the Plan 2040 Comprehensive Plan.

**SECTION III:** This Ordinance shall take effect upon its passage and approval.
