BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., A. Mayor’s Office/Louisville Metro Council, 2. Louisville Metro Council, of Ordinance No. 108, Series 2018, is hereby amended as follows:

2. LOUISVILLE METRO COUNCIL

- a. General Operations General Fund 5,735,900 5,748,400
- b. Neighborhood Development Fund General Fund 2,602,600 2,590,100

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This Ordinance shall take effect upon its passage and approval.
