REQUESTING THE RESOLUTION LOUISVILLE/JEFFERSON **PLANNING** COMMISSION SECTION REVIEW 6.1.3 OF THE TO **DEVELOPMENT** ("LDC") REGARDING **ACCESS ROADWAYS** CODE FOR RESIDENTIAL DEVELOPMENTS.

SPONSORED BY: COUNCIL MEMBER BENSON

**WHEREAS**, Section 6.1.3 of the LDC requires residential multi-family and single-family developments having 200 or more dwelling units to have two separate access roadways connecting directly to existing roadways; and

**WHEREAS**, larger developments should require additional access roadways in order to reduce traffic congestion, and the number of access roadways should be proportional to the size of the development.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:
