BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of ~~\$4,000~~ \$5,500 \$7,750 is hereby appropriated from Neighborhood Development Funds as follows: \$250 from District 3; \$500 each from Districts 1, and 6, and 23; and

\$1,000 each from Districts 2, 10, 12, and 20, 21, and 25; through the Office of Management and Budget to the Center for Women and Families, Inc. to provide funds to support a full-time salary position for a child engagement coordinator.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
