BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$6,500~~\$10,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 1; \$1,000 each from Districts 3 and 4; And \$500 each from Districts 6, 10, 22, 24, and 26; \$300 from District 14; \$250 each from Districts 15, 16, And 17; and \$200 from District 21; through the Office of

Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for program expenses associated with conducting the "Spirit of the Drum."

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
