**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$10,000 is hereby appropriated from the District 21 Neighborhood Development Funds, through the Office of Management and Budget, to the Wesley House Community Services, Inc., for staffing of the Louisville Works ESL, Computer and Job Readiness Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
