BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$10,000 is hereby appropriated from Neighborhood Development Funds as follows: \$10,000

from District 6; through the Office of Management and Budget, to the Kentucky Shakespeare Festival, Inc., for benches in

the C. Douglas Ramey Amphitheatre.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.
