AN ORDINANCE APPROPRIATING ~~\$16,800~~\$22,050 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 3; \$3,000 from District 24; \$1,500 from District 12; \$1,000 each from Districts 2, 10, 13, 14, 15, 20, 21, AND 22 and 25; \$500 FROM DISTRICTS 1, 6, 7, 16, AND 17 and 23; \$250 from district 9; \$200 from District 5; AND \$100 FROM DISTRICT 4; through the Office of Management and Budget, to the Leukemia & Lymphoma Society, Inc. for program expenses associated with "Light the Night Walk" AND OPERATING EXPENSES. (AS AMENDED)

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$16,800~~\$22,050 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 3; \$3,000 from District 24; \$1,500 from District

12; \$1,000 each from Districts 2, 10, 13, 14, 15, 20, 21, and 22 and 25; \$500 each from Districts 1, 6, 7, 16 and 17 and 23; \$250 from District 9; \$200 from District 5; and \$100 from District 4; through the Office of Management and Budget, to the Leukemia & Lymphoma Society, Inc. for program expenses associated with "Light the Night Walk" and operating expenses.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
