## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** Ordinance No. 051, Series 2020 is hereby repealed which appropriated \$6,000 from District 6 Neighborhood Development Funds to the Metro Parks Department to pay for the Community Event Jazz in Central Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be returned to the appropriate Districts' NDF account.
