BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY **METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:** 

SECTION I: The sum of \$5,001 \$6,000 \$7,000 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$2,501 \$2,500 from District 15; \$1,000 each from
Districts 13, 25, 12, 14; \$500 from District 21; through the Office of Management and Budget, to the
South Louisville Community Ministries, Inc. (SLCM) for expenses associated with the SLCM
"Families Helping Families" Fundraising Project and to support their emergency financial assistance
program.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for
a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective
at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
