**ORDINANCE NO. \_\_\_\_\_, SERIES 2017**

**AN ORDINANCE CLOSING THE NORTH/SOUTH ALLEY BETWEEN WOODBINE AND JACKSON STREETS CONTAINING 4,684 SQUARE FEET AND BEING IN LOUISVILLE METRO (CASE NO. 16STREETS1010).**

**SPONSORED BY: COUNCILWOMAN MADONNA FLOOD**

WHEREAS, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 16STREETS1010, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that closing the north/south alley between Woodbine and Jackson Streets containing 4,684 square feet and being in Louisville Metro be approved since the closing complies with the goals, objectives and plan elements of the Comprehensive Plan; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in

Case No. 16STREETS1010 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records;

**Now, therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:**

**Section I:** That the north/south alley between Woodbine and Jackson Streets containing 4,684 square feet and being in Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 16STREETS1010 and as shown on the attached alley closing plat be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**Section II:** This Ordinance shall take effect upon its passage and approval.
