**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$6,400 is hereby appropriated from Neighborhood Development Funds in the following manner: \$6,400 from District 21 to Metro Parks for Scholarships to the 2018 Beechmont Community Center Summer Camp.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
