WHEREAS, the Metro Government wishes to enter into this agreement through the Public Works & Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funds of \$293,880 for the right-of-way phase of the Louisville Loop Eastwood Cut-Off to Eastwood Rec Center segment.
